Representative Cases

- Represented a senior executive of a listed company suspected of the crime of "Breach of Trust and Harming the Interests of the Listed Company"; the case was dropped by the public security organ.

- Represented Qingdao [Certain] Mining Company in a dispute with Yichun [Certain] Mining Company over an equity transfer contract (involved amount: RMB 200 million); handled the second instance trial at the Supreme People's Court.
- Advised a listed company concerning irregular operations, representing it in the administrative penalty hearing and reconsideration process before the China Securities Regulatory Commission (CSRC).
