Professional Experience

Lawyer Zhang Meiping, a First-Grade Lawyer, is a recipient of the Special Government Allowance of Qingdao Municipal Government. Her areas of expertise include corporate legal affairs, corporate legal risk prevention, cross-border investment, financing and mergers & acquisitions, international trade, major and complex civil and commercial litigation/arbitration, and cross-border dispute resolution. With years of legal practice, she has handled over 1,000 cases and accumulated solid practical experience in both litigation and non-litigation matters. While focusing on domestic legal services, she also deeply engages in foreign-related commercial legal services, supporting enterprises in expanding their businesses to more than 20 countries and regions.
