Government Legal Advisor:

In the realm of government legal advisory services, Lawyer Wang Haijun serves as a permanent legal advisor to various government entities, including the Ministry of Ecology and Environment of the People's Republic of China, the China International Development Cooperation Agency, the

China Earthquake Administration, the Service Center of the National Intellectual Property Administration, the Beijing Municipal Ecological and Environmental Protection Inspection Center, and the State-owned Assets Supervision and Administration Commission of Chaoyang District, Beijing. During his tenure as a permanent legal advisor to these government bodies, he has participated in multiple legislative projects of national ministries and commissions, conducted legal reviews of administrative regulations and normative documents, and provided consultative advice on major policy decisions for government agencies. Lawyer Wang Haijun has also represented numerous administrative reconsideration and administrative litigation cases, covering areas such as environmental resources, intellectual property, emergency management, food and drug supervision, and industrial and commercial administration.

In the field of Environmental Protection:

In the realm of environmental administration:

Since assuming the role of legal advisor to the Ministry of Ecology and Environment in September 2016, Lawyer Wang Haijun has successfully represented nearly a hundred administrative reconsideration and litigation cases in the environmental sector. These cases encompass various areas, including applications by administrative counterparts for the competent ecological and environmental authorities to fulfill their statutory duties, government information disclosure, approvals of environmental impact assessments for construction projects, environmental protection acceptance inspections, administrative penalties, and petition handling.

In the field of environmental legislation:

Lawyer Wang Haijun has been invited to participate in the drafting and preparation work for regulations, rules, and measures related to environmental protection. Entrusted by departments and bureaus of the Ministry of Ecology and Environment, he has provided legal opinions on various legislative documents, including the "Interim Regulations on the Administration of Carbon

Emissions Trading," the "Measures for the Administration of Hazardous Waste Operation Permits," the "Measures for the Lawful Disclosure of Enterprise Environmental Information," the "Measures for the Disclosure of Environmental Information by Listed Companies," the "Measures for Public Participation in Environmental Impact Assessments," the "Regulations on the Administration of Ozone-Depleting Substances," and the "Environmental Protection Credit Evaluation Standards." He possesses systematic service capabilities in the field of environmental compliance.

In the field of environmental public interest:

The environmental elements involved in the ecological damage compensation or environmental public interest litigation cases represented by Lawyer Wang Haijun include, but are not limited to, hazardous waste, atmospheric pollution, water pollution, soil contamination, noise pollution, and radioactive substances. Notable representative cases include:

- Representing the Haixi Mongolian and Tibetan Autonomous Prefecture in Qinghai Province in filing ecological damage compensation claims against 14 energy enterprises for environmental pollution in the Muli mining area.
- Representing a series of environmental public interest litigation cases concerning atmospheric pollution from gasoline and diesel vehicles, thereby promoting research on policies for environmental governance of mobile pollution sources.
- Representing a series of environmental public interest litigation cases related to pollution in the Tengger Desert, which were listed as typical cases by the Supreme People's Court. The team for these cases was also honored as the CCTV Legal Figures of the Year in 2015.

In the field of intellectual property:

Lawyer Wang Haijun holds qualifications as both a patent agent and a trademark agent. He has

represented a series of trademark cases involving Shandong Deheng and Beijing DeHeng Law Offices. Other notable intellectual property cases he has handled include the trademark rights confirmation cases for the "Friendly Shandong" and "Shandong You Li" series; the recognition case for the well-known trademark "Hospitable Shandong"; the unfair competition case concerning the conflict between the business name "Qing-Feng Baozi Restaurant" and its trademark; the case involving the conflict between copyright and trademark rights for "Doraemon"; the trademark rights confirmation case for Google's Gmail; the case concerning the infringement of scientific and technological achievements rights by the "National Occupational Injury Identification Standards"; and the antitrust case against Tencent for abuse of market dominance, among other trademark rights confirmation and protection cases.
