Professional Experience

Attorney Yang Qiao began her legal practice in 2007, specializing in administrative and criminal law. She defended Zhu XX in a case of alleged affray, resulting in the procuratorate's decision not to prosecute; defended Zhu XX in a case of organizing and leading pyramid scheme activities, achieving a reduced sentence of one year in prison for the defendant; defended Yin XX in a case of forging official documents, certificates, and seals of state organs, resulting in the procuratorate's decision not to approve the arrest; and defended Lu XX, a member of a major drug trafficking ring, where the defendant received a sentence of 10 years in prison.
